THE STATION HAS A CONSTRUCTION PERMIT FOR DISPLACEMENT TO DIGITAL CHANNEL 48 THAT EXPIRED WITHOUT CONSTRUCTION BEING COMPLETED BECAUSE THE LICENSEE HAS EXPERIENCED SEVERE FINANCIAL STRESSES DURING THE RECENT ECONOMIC DOWNTURN.
