# Missouri Broadcasters Association

## Request for the Performance of a "Mock Inspection"

Station KBPB requests a "mock inspection" of it facilities  
 located: 10795 65 North, Hampton, AR 72662  
 Hwy.

It is understood that this inspection will occur without prior notification at a time, within a four month period, to be determined by the MBA office. Station will be advised of the four month period upon receipt of this signed agreement and all fees by the MBA office.

Upon completion of the inspection the station will receive a listing of all potential violations, an opinion of severity, and an accounting of any potential forfeitures. It is the responsibility of the station to correct any area of non-compliance. The Missouri Broadcasters Association, its members, officers, board of directors, and staff assume no responsibility and make no guarantees beyond those listed above.

The inspector is an employee of the MBA not the Federal Communications Commission. Any non-compliance will not be reported to the FCC or any other governmental agency. However, notice will be forwarded to the FCC field office in Kansas City, Missouri of those stations found "in compliance". Stations found "in-compliance" by the MBA inspector will then be granted a three (3) year grace period, during which time stations will be exempted from further routine inspections by the Kansas City office of the FCC. The grace period will apply except in those instances relating to external triggers such as a formal complaint being filled with the FCC or an order, by the FCC in Washington, DC, for specific or general inspections.

Should the FCC come to a station to perform a normal routine inspection, unrelated to any external triggers, before the ordered MBA inspection is completed, the station should produce a copy of this agreement. The FCC inspector will not proceed with the inspection at that time and the station will have four months for the MBA "In compliance" notice to be received by the FCC regional office in Kansas City.

This agreement does not cover Equal Employment Opportunity compliance. Stations are, as always, encouraged to make special efforts to make certain they are in compliance with the rules and regulations governing this area. Compliance with FCC political broadcast rules will only be inspected and certified to the extent that stations can demonstrate that current information on political broadcasts is correctly contained in the public file.

Station agrees to retain three (3) copies of this agreement within its facility at all times. The distribution of these copies shall be as follows: one copy to be retained by the General Manager or Station Manager and two copies to be distributed to key staff personnel familiar with this agreement, the MBA "mock inspection" program, and FCC procedures.

Station agrees to provide the MBA inspector with the necessary staff support and cooperation to accomplish the inspection and to behave towards the MBA inspector with courtesy and respect at all times.

It is agreed that the Missouri Broadcasters Association, its members, officers, board of directors, and staff shall be held harmless should an official inspection by any governmental agency result in fines, forfeitures, or any other punitive actions.

**Station to be inspected is a: (check one)**

- Single, non-directional AM or a single FM (\$200.00)                       AM/FM combo with AM non-directional (\$300.00 Fee)
- Duopoly (\$300 base fee + \$100 for every station above two)                       Additional monitoring points \$20 each
- Directional AM add \$175 (includes 5 monitoring points)                       Television Station (\$350.00 Fee)
- Re-inspections (50% of the above fee schedule with the exception of AM directional which remains full fee)
